Jury Report I “Hangar Ticinum”

On Friday 10/12/2021 at 11:59 pm (CET) *TerraViva Competitions* has officially closed the submission of the proposals for the contest “Hangar Ticinum” On Monday 13/12/2021 the jury panel was divided into two groups of four members. Each group was in charge of evaluating half of the submitted projects:

The judges have received all the submitted proposals in digital format, together with the instructions regarding the evaluation procedure and the “Evaluation Criteria” previously published in the official competition brief (available on www.terravivacompetitions.com).

The first phase of the evaluation round lasted 23 days.

On Tuesday 04/01/2022 all the jury members expressed their votes and the “Top 30” finalists were selected.

On Wednesday 05/01/2022 the second phase of the evaluation process officially started. A new and deeper analysis of the selected proposals was carried out during the following 5 days by all the jury members.

On Friday 15/01/2022 the judges expressed their final votes regarding the finalists, concluding with the selection of the award winning projects (1st - 2nd - 3rd prizes, 4 Golden Mentions and 10 Honorable Mentions).
