GIFT CARD GENERAL TERMS AND CONDITIONS OF USE

The purchase or use of the Card entails the acceptance of these terms and conditions, which have been made available to the customer upon purchase of the Card, and which are also available on www.terravivacompetitions.com. The issuer may modify these terms and conditions without notice.

1. The Gift Card (hereinafter, the "Card" or the "Cards") is the property of the issuer, TerraViva S.r.l., with registered office in Milan, Via Vallazze n. 109, C.F./P.I.V.A. 12608970963, N. REA MI-2672012, (hereinafter "TerraViva"). The Cardholder is considered a mere depository of the Card.
2. The Card is valid only for the payment of a registration fee for a competition chosen from all those promoted by TerraViva not later than 31/12/2023 on the dedicated page of the Website www.terravivacompetitions.com.
3. The Card allows to enter a competition organised by TerraViva in 2023, regardless of the registration period (Early, Standard or Late Registration), always free of charge, using the unique code at the time of payment.
4. The Card can be purchased using the payment methods accepted on the Website www.terravivacompetitions.com. The Card cannot be purchased using another Gift Card.
5. The Card that has not been used cannot be returned and/or refunded.
6. The Card can only be used to register for a single competition, is not valid for the purchase of multiple promotional packages and/or other Cards and has a value of Euro 69.00 (+VAT).
7. The sale of Cards is subject to availability.
8. Registration fees paid with the Card at the Website www.terravivacompetitions.com are subject to the same general terms and conditions as any other registration fee paid on the Website www.terravivacompetitions.com.
9. In case of payment of a registration fee by Card and subsequent exercise of the withdrawal from the registration to the competition, the refund will be made by crediting back on the Card the credit used. There is no form of cash refund.
10. At the time of purchase the Card will be provided in electronic format and sent by e-mail in a pdf file that will contain the instructions for use and a unique secret code valid for the use of the Card, containing the relative detailed information. The Card is delivered by e-mail to the designated person, whose details are provided upon purchasing. The use of the Card does not involve any additional cost.
11. The Card is not nominative and can be transferred to third parties and used by anyone presenting it for the payment of the registration fee and those who purchase it do not necessarily have to participate in the competition. The Cardholder is solely responsible for the use and safekeeping of the Card. In case of theft, loss or damage, the Card will not be replaced. In any case TerraViva may replace the Card in case of change in the format of the Card itself.
12. Risk of loss and ownership of the Card shall pass to the purchaser upon electronic transmission of the Card to the purchaser or designated recipient.

TerraViva will not be responsible for the non-receipt or delay in receiving the Card purchased by the recipient due to force majeure and causes in any case not attributable in any way and within the maximum limits permitted by current legislation to TerraViva such as, by way of example and not exhaustively: (i) poor functioning or interruption of telecommunications lines and/or systems, (ii) delay in the transmission of information or data or the loss of information or data that may occur for one of the causes indicated in point (i) above, (iii) the inaccuracy of the data of the recipient of the Card provided by the purchaser of the Card itself, (iv) the fact that the e-mail sent by TerraViva is considered as spam or junk mail.
14. Cards obtained by any fraudulent or illegal means will be considered null and void, cannot be used for the payment of registration fees and the purchase price cannot be refunded.
15. The Card may not be used for advertising purposes or promotion of products or services marketed by third parties unrelated to the issuer of the Card, unless previously authorized by TerraViva.
16. The Card merely allows a payment method and is not intended in any way as an investment instrument and/or a solicitation of savings.
17. There are no purchase limits on Cards, but all Cards must be used by 31/12/2023. Upon expiry of its validity, the Card cannot be renewed or used for the payment of registration fees and the value of the Card cannot be refunded or converted into cash.
18. In accordance with the Italian Consumer Code (D.lgs. 206/2005), the right of withdrawal may be exercised within 14 days from the day of receipt of the e-mail containing the Card (weekends and public holidays included). In any case, the right of withdrawal cannot be exercised after the use of the Card. Refunds are executed in the same currency of the original payment and are therefore subject to currency exchange rates. To exercise the right of withdrawal, write to: info@terravivacompetition.com.
19. The purchase of a Card involves the communication of personal data of the person making the purchase, which will be processed by the company in accordance with current legislation on personal data protection, as specified in the "Privacy" section on the Website www.terravivacompetitions.com.
20. When you purchase, receive or use a Card, you agree that these general conditions of use of the Cards are governed by Italian law. Any dispute concerning the use of a Card will be settled by the Court of Milan.
